### When can we use Certifydoc?

#### - Certify the state of the places

Certification with certain date and integrity of all the documentation related to the basic and executive projects.

#### - Technical inspections

Strengthen the technical inspections of buildings for preventive legal maintenance, according to local laws

#### - Certificate of energy efficiency

Date certain and integrity of all the documentation of the energy efficiency certificate of a property.

#### - Certificate of occupancy

Certification of all the documentation of the occupancy certificate to certify that the house meets the basic conditions of health, hygiene and solidity in notary public, comprehensive reforms and mortgages.

#### - Procedures

It certifies all the important documentation such as: maintenance, contracts, annexes, procedures, receipts, accounting, communications, current accounts, employees, personal data, fees, debts, suppliers, follow-up of insurance and claims, etc. It also uses the certification as a deterrent for clients who would otherwise try to breach contracts, thus avoids conflicts.

Procedures of all kinds before any state, regional, provincial or municipal body.

State agencies are required to comply with regulations and give value to evidence accredited by state authorities, such as those granted by Certifydoc through the service providers of the corresponding state Ministry inside the EU.

#### - Building demolitions

Certification of the state of the streets, sidewalks and adjoining buildings of the pre and post - demolition for insurance purposes and to reduce the responsibility for damages not caused by the demolition work.

#### - Expert Reports

Reinforce the legal relevance of all the documentation related to the expert reports of the architects with a date certain and integrity granted by the qualified time stamp of the EU, according to the eIDAS Regulation.

## Legal

According to current law, photos, videos and electronic documents have very low legal relevance because their content and date can be easily manipulated. So how can I protect myself to prove the status of a property at a given time?

Without Certifydoc the documentary evidence is uncertain.
