## When can we use Certifydoc?

#### - Invoices and Contracts

We receive an abusive invoice or one that does not correspond to what was promised or published in the web offers. We certify both documents and file a claim, including evidence of high legal relevance, by sending the email resulting from the certification to our consumer association.

#### - Screenshots

Our airline does not reimburse us for the amount of the ticket, even though it is stated in the purchase conditions of your private area. The company only tries to transform that refund into flight credit or misappropriate the amount, making it impossible to contact or produce the required documentation within the arbitrarily imposed deadlines.

We capture the screen of the conditions and the answers of the internal chat of the company portal, to be able to demonstrate the non-compliance with date certain and integrity. Then we certify it, sending the email resulting from the certification to our consumer association.

#### - Videos from the web

We see a video on the web where they promise us a "satisfied or refunded" offer and when we want the refund it never happens. We record the promotional video with a mobile and certify it. We will now have evidence of certified legal value.

#### - Phone conversations

We are harassed with numerous calls from telemarketers asking us to switch provider without consent. Alarmed by the experience of others, we recorded the conversation and certified it. Without much surprise, a few days later, we find a contract change proposal that we have not requested with conditions that do not correspond to those promised by phone.

The certifications allow us to negotiate and nullify these abusive actions.

#### - Whatsapp messages

We need technical assistance on an appliance still under 2-year warranty according to EU regulations. The seller's technical service contacts us by whatsapp saying that they guarantee only one year of warranty and only for some spare parts.

We recorded the whatsapp conversation and all the excuses and refusals with another mobile and certified it with date certain and integrity, in order to prove the attempted violation of consumer rights.

## Legal

According to current law, photos, videos and electronic documents have very low legal relevance because their content and date can be easily manipulated. So how can I protect myself to prove the status of a property at a given time?
