

With this innovative **#legaltech solution** everything is simplified, the ease of use of our technology, the use of qualified service providers and the long-term validity of the certifications granted by them, provide two fundamental instruments in a single tool (qualified time stamping and strong encryption) to carry out the expert appraisals efficiently.

The delivery of the certification in email format is intended to be explained to the court and clearly understood, either as documentary evidence, or at the time of the hearing. A comfortable PDF to print can be presented as a reference to the digital evidence. The verification and validity of the certification can be carried out at any time also during the viewing, with independent third-party tools (XolidoSign, for example).

The email received as a result of the certification is **self-consistent**, which means that from that moment the user will not depend on any intermediary to keep and use their digital proof. Simply by saving the email on the hard drive in '.eml' format, everything necessary to verify its legal value can be safely and easily archived.



What competitive advantages does Certifydoc offer to computer forensic experts?

To preserve the **chain of custody**, Certifydoc allows a qualified time stamp to be given to the hash (fingerprint) of any image or hard disk, since the investigations are carried out on the copies made and the originals must remain unaltered and secured.

To certify with Certifydoc **is so simple** that it can be done at any time just by registering, without subscriptions or permanence, with any smartphone or PC device.

Only what is consumed at the moment is paid online. The cost of a certification is €2 + VAT.

The service allows you to gather, in a single shipment, any document (computer expert report, technical documentation, emails, whatsapp messages, etc.) without limitation of type or number of files, up to a total of 17 MB per certification. In this way the certified evidence can be received, shared and archived easily and securely.

In the case of certifying files with no size limit or entire hard drives, Certifydoc offers a specific guided process for experts that certifies the 'hash' produced in a few seconds.

With regard to privacy, Certifydoc has implemented a **restrictive interpretation** of the current local EU states and GDPR regulations in various aspects: each file preparation process takes place rigorously on the user's device; files can be strongly encrypted (with AES256 algorithm) before sending them with secure protocol (SSL); Finally, Certifydoc instantly deletes all the files sent from its servers once the certification email has been sent to the user. These aspects are highly relevant in court cases and in cases of handling highly sensitive data.

Computer Expert Reports

- Preparation of computerized expert report and its defense before the judicial or arbitration authority.
- Analysis of technical documentation in judicial sentences and plagiarism in computer software systems.
- Authentication and certification of emails and whatsapp messages.

- Analysis of computer files to determine their integrity or manipulation (photographs, audios, videos, etc).

Legal

According to current law, photos, videos and electronic documents have very low legal relevance because their content and date can be easily manipulated. So how can I protect myself to prove the status of a property at a given time?
